GO KART TRACK SUPPLEMENT APPLICATION

The following conditions would apply, and the policy would carry an endorsement to this effect. We will only consider if you agree to these conditions. If you agree to accept these warranties, acknowledge by signing and dating where indicated below:

1. All go-karts are provided with drive guards, safety shoulder harnesses, padded steering wheels, rear head protection, and helmets available for use.
2. All karts are restricted to one person in 1-seater karts, 2 persons in 2-seat karts, with minimum age being no less than 8 years old and minimum height being no less than 52".
3. Shoes/Shirts and helmets must be worn at all times and long hair must be put up/contained.
4. If more than 10 karts allowed on track at any one time, entry not adequately spaced, and /or karts are not governed to a maximum speed of 20 MPH, attach thorough explanation.
5. Signs must be visibly posted stating all track rules, track must be fully supervised at all times during hours of operation/open, and supervisors must be instructed in safety procedures and operational procedures.
6. Track must be fenced, with protected corners/curves (i.e., hay bails, tires or other safety/cushioning materials) and the premises must be equipped with telephone for emergency use.
7. There are no events, operations, races or uses of the karts or track at any time other than as so specified and designated in this application and operations of the insured karts are restricted to the premises designated in this application.
8. The fueling procedure is handled under the strictest safety standards and with no persons other than employees of the insured being allowed in the fueling area.
9. There is no racing, time trials or individually owned vehicles allowed on the track.
